Eligible Purchases

Bookstore vouchers may be used for educational materials and supplies available through the Trinity College Bookstore, including:

- Required or recommended textbooks and course materials
- Notebooks, binders, pens, pencils, and other classroom supplies
- Calculators and other required academic supplies
- Course-specific materials or equipment
- Other educational materials approved by the College

Items Not Eligible for Purchase

Bookstore vouchers may **not** be used for:

- Clothing or apparel
- Food or beverages
- Toiletries or personal-care products
- Gift cards
- General merchandise unrelated to academic coursework
- Other items determined by the College to be outside the purpose of the voucher program

Student Authorization & Acknowledgement

By signing below, I understand and agree that:

1. **The bookstore voucher is not additional financial aid, a scholarship, grant, loan, or additional College funding.**
2. The voucher allows me to charge my student account for eligible purchases at the Trinity College Bookstore.
3. Only the **actual amount I spend** at the Trinity College Bookstore will be charged to my student account.
4. If I have credit on my student account, any bookstore charge made through this voucher will **reduce** the amount of any credit balance otherwise available to be refunded to me.
If, for example, I have a \$1,000 credit balance and use \$300 at the bookstore, the \$300 bookstore purchase will be charged to my student account and my remaining anticipated credit will be reduced to \$700.
5. Approval of a voucher does not guarantee that my student account will remain in credit status. Changes to enrollment, financial aid eligibility, outside resources, charges, or other account activity may change my final account balance.
6. If my financial aid or student account changes and there are insufficient funds to cover my bookstore purchases, **I am responsible for any resulting balance owed to Trinity College.**
7. This authorization is valid only for the academic term identified above and may only be used by me at the Trinity College Bookstore.
