Meeting Minutes

Welcome from TCAA President Scott Lessne '80:

TCAA President Scott Lessne called the meeting to order at 12:45 p.m.

Mr. Lessne shared a welcome and expressed his gratitude for the privilege of serving as TCAA President.

Mr. Lessne referenced the minutes of the last annual meeting in June 2025 and noted that this was the first annual meeting of the Alumni Association to take place in-person since the COVID-19 pandemic.

On motion duly made and seconded, the minutes of the June 2025 meeting were approved by the members of the Alumni Association.

Mr. Lessne discussed the history of the TCAA and its role as a voice for the alumni. Mr. Lessne additionally discussed expanding the accessibility of the TCAA website and the information available and the forthcoming initiatives of the TCAA Executive Committee.

Mr. Lessne also referenced the TCAA Executive Committee's participation at 93% and discussed the importance of giving in support of the College.

Voting

Mr. Lessne explained the voting process and called for two votes (conducted by acclamation) as follows. The first vote was to re-elect four members to their second term on the TCAA Executive Committee: Rick Ewing '89, Alan Katz '93, George Malhame '78, and Marvin Pierre '06. The second vote was to elect one member to their first term on the TCAA Executive Committee: Jeffrey Kollman '01.

Mr. Lessne shared the 2026-2028 officer slate of the Alumni Association as follows:

On motion duly made and seconded, the slate was approved without opposition and the above members were duly elected to terms of three years and the officers were duly elected to terms of two years.
