## Important: Prepare for TrinCore Changeover

To ensure a smooth transition and avoid delays, we recommend everyone:

- Submit and approve all remaining vacation and sick leave for both November and December <u>by Friday, December 12</u>, using this link.
- Download your pay slip history: If you need or want personal copies of past pay slips, please download them from PeopleSoft before December 22.
- Pause WB Mason Orders in Unimarket: Place all WB Mason orders by December 19 and receive all open orders by that time. Purchasing will resume after the new year.
- Plan for potential delays: Because we will minimize changes to PeopleSoft during the data migration period (November 19 – December 10), some processes may experience delays. We appreciate your patience and understanding during this transition.

#### Key Dates:

- November 19, 2025 (5:00 p.m.) December 10, 2025 (Data Migration Period): During this time, PeopleSoft will remain operational, but we ask that everyone minimize changes to the system to ensure data integrity during migration.
- December 22, 2025 (Go Live): The new ERP system launches just as we begin our winter break. When we return in January 2026, we'll be working in the new system.
- April 15, 2026 (PeopleSoft Self-Service Grace Period): PeopleSoft self-service capabilities will remain available in limited, read-only capacity through April 15 to support tax-related information needs.
- December 15: we will share information on January training and support options, as well as the timeline for the remaining
  implementations that will take place through the summer of 2026.
